INSURANCE	application support letter must be sent to. The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness (including COVID-19), repatriation and the like. The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and repatriation for all the members of their Delegation. Basic insurance (sickness, accident and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance. The information regarding the LOC Safeguarding Officer will be communicated upon arrival of the delegations on site. In addition, posters of the "10 Golden Rules of Gymnastics", the FIG campaign to raise awareness about youth protection in Gymnastics, will have to be displayed in several locations, including training and warm-up halls and public zones.
INTERNATIONAL TRANSPORTATION	The invited participating delegations must pay for the travel costs of their delegation members. The Travel Schedule Form must be returned to the LOC by 10 March 2024.
LOCAL TRANSPORTATION	Local transportation between Luxembourg Airport (LUX)/ Luxembourg train station and the official hotels as well as between the official hotels and the competition venue will be provided by the LOC for all delegation members from the official arrival day to the official departure day.
