	NFs must declare through the gymnast's FIG profile whether their 18-year-old gymnasts will compete as junior or senior prior to their first competition for the year concerned (according to FIG Technical Regulations 2025, Section 1, Art. 5.2 Age of Participants).  WAG Juniors, as per FIG technical regulations WAG Seniors, as per FIG technical regulations All gymnasts must have a FIG license valid until the end of the event.		
JUDGES AND JURIES	For MAG and WAG, Senior and Junior, the participating member federations must send qualified judges according to the following rules (MAG and WAG):  - 1 Junior OR 1 Senior Team = 1 judge - 1 Junior Team AND 1 Senior Team = 2 Teams = 2 judges - 1 – 3 Junior individuals OR 1 – 3 Senior individuals = 1 judge - 1 – 3 Junior individuals AND 1 – 3 Senior individuals = 2 judges - (1 Junior Team OR 1 Senior Team) AND (1 – 3 Junior individuals OR 1 – 3 Senior individuals) = 2 judges - 1 Junior Team AND 1 Senior Team AND (1 – 3 Junior individuals OR 1 – 3 Senior individuals) = 3 judges - (1 Junior Team OR 1 Senior Team) AND 1 – 3 Junior individuals AND 1 – 3 Senior individuals = 3 judges - 1 Junior Team AND 1 Senior Team AND 1 – 3 Junior individuals AND 1 – 3 Senior individuals = 4 judges  All judges must have a current valid FIG brevet at the time of the event, for the respective discipline. Time and Line may be National judges. Failure to provide judges as mentioned above at the time of the definitive registration will result in a LOC charge of EUR 1,000 per judge to the federation concerned (non-refundable). This fine must be received on the FLGym account not later than 10 March 2025.  Depending on the number of participating teams and judges, the LOC will determine the number of Apparatus Juries (judges' panels).		
REGISTRATION DEADLINES	Please use the respective forms.  Definitive registration:  10 February 2025 (2 months before event)  Nominative registration:  Registrations will only be accepted through national federations.  Please note: The definitive registration can be seen as your application for participation. The LOC will send out participation confirmations the day after the definitive registration deadline at the latest. It is as the discretion of the LOC to allocate the starting places and only after the LOC's confirmation your participation is guaranteed.		
ENTRY FEES	No Entry Fee will be applied for this event for all delegation members who book their accommodation through the LOC.  Delegations that will not book their accommodation through the LOC will have to pay an entry fee of EUR 150 per person.  The payment to the LOC must be received on the account no later than 10 February 2025 (refer to "bank account information" below). The entry fee is non-refundable. Entries without payment of the entry fees in time will be considered as invalid and will be refused.		
ACCREDITATION	Accreditation will be given to all members of the delegation upon arrival and when all costs have been paid.  In addition, the LOC will distribute information regarding the gymnasts' safeguarding plan.

INSURANCE	application support letter must be sent to.  The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness (including COVID-19), repatriation and the like.  The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and repatriation for all the members of their Delegation.
	Basic insurance (sickness, accident and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance. SAFEGUARDING	From the official event day of arrival until the official day of departure, participants (gymnasts, coaches, judges and any other delegation members) have the possibility to contact by phone or e-mail the LOC Safeguarding Officer in case of harassment and abuse of any type or if they are worried and do not feel comfortable.  The information regarding the LOC Safeguarding Officer will be communicated upon arrival of the delegations on site.  In addition, posters of the "10 Golden Rules of Gymnastics", the FIG campaign to raise awareness about youth protection in Gymnastics, will have to be displayed in several locations, including training and warm-up halls and public zones.
INTERNATIONAL TRANSPORTATION	The invited participating delegations must pay for the travel costs of their delegation members. The Travel Schedule Form must be returned to the LOC by 10 March 2025.
TRANSPORTATION	Local transportation between Luxembourg Airport (LUX)/ Luxembourg train station and the official hotel as well as between the official hotel and the competition venue will be provided by the LOC for all delegation members from the official arrival day to the official departure day.  All delegations that have not booked their accommodation with the LOC have to organize their local transportation on their own.  Pickup and drop-off at the airport/ train station can only be guaranteed if the Travel Schedule Form is returned to the LOC by 10 March 2025.  Delegations arriving earlier and departing later than the specified event period have to organize and pay for their local transport outside the covered event slot themselves.
